# Sanli Environmental secured contracts totalling \$\$78.9 million

SINGAPORE, 5 September 2022 – SGX-Catalist listed Sanli Environmental Limited ("Sanli", "the Company", "三立环境有限公司" and together with its subsidiaries, the "Group"), one of Singapore's leading environmental engineering companies, is pleased to announce that it has secured new contracts from multiple customers worth an aggregate of S\$78.9 million since our last announcement on 26 May 2022 and they are expected to be completed by early 2027 (the "Contracts"). These Contracts comprise projects in both Engineering, Procurement and Construction ("EPC") and Operations and Maintenance ("O&M") segments.

The current orderbook of the Group stands at S\$371.4 million and is expected to be completed by early 2027.

Barring any unforeseen circumstances, the Contracts are expected to have a positive impact on the net tangible assets and earnings per share of the Group for the financial year ending 31 March 2023.

None of the Directors and controlling shareholders of the Company, as well as their respective associates, has any interest, direct or indirect, in new contracts, save for their shareholdings in the Company (if any).
